Firewise

One of the benefits of being a Firewise USA Site is having a close relationship with our local fire department. In 2019, they helped us to acquire and to train a few of us to use our AED (Automated External Defibrillator). We would very much like to have another training session at our Community Center this fall. This will include CPR and AED Training. If this is something you would be interested to learn or get a refresher, please contact your Firewise Director (Charlie Bennett) right away as the number of trainers relates to the amount of people attending the training. You can reply to this email or call or text me. Also this year, Reflection Lake became a model community for Spokane County and Washington State in the Wildfire Ready Neighbors Program. We were proud to have Hilary Franz, the Commissioner of Public Lands, announce the passage of H.B. 1168 at Reflection Lake. This bill is the \$125 million wildfire bill which contains funding for communities like us in our efforts to mitigate the spreading of wildfires in our area. (continued page 5)

This year they provided us with five-40 yard dumpsters, a promise to pay for our draft site (dry hydrant) in the spring, and \$2000 toward the cleanup of Lot one and demolition of the trailer which cannot be moved. *(continued page 5)*

Please turn in your estimated hours spent on your property or helping others to make our community more adaptive to surviving a wildfire in our area. This includes raking leaves or pine needles, cleaning gutters, safely burning debris, etc. These hours provide a guideline for the DNR and state agencies to estimate how much to help us next year in the form of grants and other services.

Roads

There have been a lot of ups and downs this year with many bumps to smooth out. We have been working on drainage, new speed limit signs and planning projects for years to come. One such project the roads committee has been racking our brains on is the condition of our private roads. But who and how we will pay for them? At the annual meeting a special account was approved to start saving for this massive project by fundraising and donations. The whole lake benefits from the quality of the east side roads with their access to Bald Eagle Beach, Turtle Beach and our Community Center. But the financial burden falls directly to the east side to fix the road. A heavy burden, no doubt. A burden too large for the east side to carry alone. One solution we have come up with is to ask for donations from those around the lake who are interested in helping to donate to the roads committee account. This would give us a jumpstart and lessen the burden to the east side. There are other ways you can help too, by joining the roads committee, helping with fundraising, and other projects that benefit the community. We are still working on a mediated agreement to bring the lawsuits to an end still leaving us with a possible pile of mediation legal bills and we may still be heading to court. Our financial status has been impacted by the law suits resulting in additional costs to all of us.

The new lake budget started on 1 October. Please contact me if you are on the delinquent dues list to avoid a lien being placed in December.

Legal Update

I would like to believe that by Spring of 2022, Reflection Lake will be everything that our friends at Firewise U.S.A. and Washington State think we are: that is a community which represents the model of volunteerism and common interest, working together to leave things better than we found them.

To date, around \$50,000 has been paid to lawyers by this community. Approximately \$30,000 of that amount has been donated by 25 members of the RLCA. The RLCA Board entered in good faith mediation on August 24th determined to satisfy our plaintiffs demands and we thought we had accomplished that goal. However, since then the lawyers have been hard at work on reaching a compromise on the mediation agreement. At this time, there is still no signed agreement and the costs continue. If successful, these lawsuits would effectively change our covenants which require a vote of 2/3 majority of the members.

The very same people who are suing this community were on the 2020 RLCA Appointed Board. They could have re-written the covenants and let the members vote. Instead, they hired lawyers to block elections and to force paid management on the members.
